

**East Park Reservoir  
2012 Wild Pig Hunts**

The California Department of Fish and Game (DFG) is permitted by the United States Bureau of Reclamation (USBR) to conduct a limited public entry, permit-only pig hunt to control a small population of wild pigs on a portion of East Park Reservoir in western Colusa County. The area consists of grassland, oak woodland, brush and some wetland areas.

Individual hunters may be accompanied by not more than one non-hunter. No more than three hunters will be allowed to hunt at any given time. **Only muzzleloading rifles** as described in [Title 14, Section 353](#) (CCR) may be used. No vehicles (OHVs included) or dogs may be used. A pre-hunt orientation is mandatory, and all hunters are required to check in and check out of the hunt area. DFG personnel will be onsite during the hunts.

Hunts are planned for the months of April, October and December 2012 as listed below. The dates provided are preliminary and subject to change, but the deadlines for applications will remain fixed. Hunters should read the hunt instructions carefully to ensure an application is eligible for the drawing.

**To Apply:** Hunter may [apply online](#) or through the U.S. Postal Service. Online application will be open during the dates listed above. **Two-day pig hunt permits** will be issued to hunters by drawing only for all pig hunt periods. Each hunter may apply only once, for as many hunt periods as they can attend, though a hunter cannot be drawn more than once. No party applications or incomplete applications will be accepted – must include a phone number to be entered for the drawing. There is no fee to apply.

Results will be posted online and successful applicants will be mailed permits, maps and additional information two weeks after the application deadline.
